Legisladores Declaran Vacante la Presidencia del Perú

LIMA, (Reuter). Un grupo de legisladores declararon ayer vacante la presidencia de Perú, por considerar que el presidente Alberto Fujimori violó la Constitución al ordenar la disolución temporal del Congreso como medida previa a su reorganización. El documento de cuatro puntos fue redactado con la participación de varios legisladores que se encontraban reunidos frente al domicilio del presidente de la Cámara de Diputados, Roberto Ramirez del Villar. El comunicado leído a la prensa por Oscar Urbola, primer secretario del Congreso, informa que "el ciudadano Alberto Fujimori ha incurrido en una violación flagrante de la Constitución al pretender subvertir el orden democrático". ...The economic situation continues to be extremely critical for the estimated 13 million Peruvians - out of a population of 22 million - who live in acute poverty. While the minimum monthly expenses in October 1991, for a family of four, were approximately 480 soles, the minimum monthly wage was 38 soles. It takes about eleven minimum wages to meet a family's basic needs. The government reduced its already inadequate health and education budgets in 1991 and is proposing the privatization of education. While 20% of the national budget is earmarked to service the country's external debt, only 11.3% is destined for education, health and housing. Increasingly, the government has resorted to the use of barbarism to deal with barbarism. In the first 15 months of the Fujimori government 4,075 people were assassinated in political violence (9,660 were assassinated during the previous administration). They were victims of government security forces, civil defense committees and paramilitary groups, as well as the insurgent forces of Sendero Luminoso and Movimiento Revolucionario Tupac Amaru. More than 60% of those who have been killed are peasants. Church and human rights workers, journalists, elector officials, development workers and university staff have received death threats and have become targets of assassination. It appears that for the fifth year in a row, Peru will be named by the United Nations as the country that has recorded more disappearances during the year than any other
