Dear Mr. President,

I would respectfully like to draw Your attention on the death of Nelson Wladimiro Curiñir Lincoqueo, a 22-year-old Mapuche Indian, student at the State Techinical University in Temuco and activist in the Communist Party.

On 5 October 1973 a heavily armed group of men in air force uniform entered the home of Nelson Wladimiro Curiñir Lincoqueo and told the family that they were taking Nelson Curiñir to the Maquehua air force base and that he would then be transferred to Temuco prison. His family never saw him again.

In March 1990 a Mapuche Indian stated that the body of Nelson Curinir had been found on the banks of the River Cautin in 1973 and that he had been buried as "NN" (name unknown) in a cemetery near Temuco. The National Commission of Truth and Reconciliation (CNVR) presented Nelson Curinir's case to a civilian court for investigation. On the order of the civilian judge the body of Nelson Curinir was exhumed in November 1990 and identified by his family. A criminal complaint for homicide was presented to the courts in 1991.

I would like to welcome the investigations already carried out into this case and to express my hope that in the course of further investigations the full truth will emerge and those responsible for the killing of Nelson Curiñir will be brought to justice.

I would also like to note that this case is one of the over 2.000 incidents of human rights abuses examined by the CNVR and one of the more than 100 cases concerning Mapuche Indians. In all these cases the commission established gross human rights abuses, the perpetrators of which have never been brought to justice because of the amnesty law passed in 1978, which constitutes an obstacle in clarifying past abuses. Therefore I believe that this law should be repealed so as to facilitate further investigations into reported human rights violations and the bringing to justice of all those responsible for them.

Being convinced that only the full clarification of the past will lead to a genuine reconciliation and prevent the recurrence of atrocities, I am appealing to You to undertake everything within Your power to contribute to this process and remain
