Dear Mr. Presidente:

I have read with dismat about the murder of Nelson Wladimiro Curinir Lincoqueo, a Mapuche Indian. I understand that the National Commission of Truth and Reconciliation presented the case to a civilian court for investigation in 1990, and that a criminal complaint for homicide was presented to the courts in 1991. His murderers have never been punished.

I also understand that it was not your government that did this and other horrendous crimes against your indigenous peoples. However, I am writing to ask you to take special steps to help your native peoples which I understand make up six per cent of your population.

Perhaps you think it impertinent of a "gringo" to be writing. This is probably especially annoying to you in view of the mistreatment of Native Americans/Indians in my own country. Well, believe me, I write to the American government too. The situation concerning the Native Indigenous Peoples in the Western Hemisphere is appalling to me and many like me.

I try to do my part to help. However, I am not so fortunate as you are—as head of your country you can do much to reverse the sad plaight of the Indigenous Peoples of Chile.
