

I want respectfully to express my serious concern about the possible transferral to military jurisdiction of investigations into the torture & "disappearance" of Alfonso Chanfreau Oyares in the context of the repeated failure of the military courts to investigate cases of human rights violations & to bring those responsible to justice. I also want to express Amnesty International's concern about the impunity of those responsible for human rights violations during the former military government & urge the government to ensure that those responsible are brought to justice so that the full truth in cases like that of Alfonso Chanfreau Oyares can be revealed.

I respectfully request the government to repeal the 1978 Amnesty Law (Law 2191) which has prevented & obstructed full judicial investigation into abuses committed before 1978.

Thank you for your consideration of my requests which I really believe in since I am a Christian.

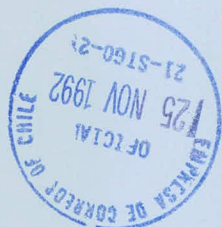
