


Your kind assistance all along the Commission was a precious contribution in the advancement of the protection of human rights and the safeguard of fundamental freedoms in that area.

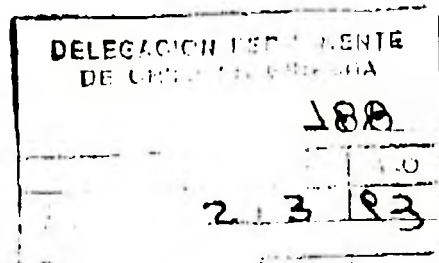
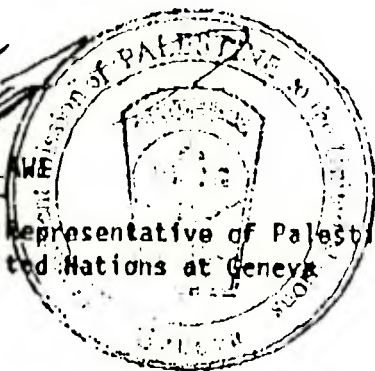
