Your Excellency,

I am concerned to learn of the death after abduction by the security forces in October 1973 of NELSON WLADIMIRO CURINIR LINCOQUEO, a 22-year-old Mapuche Indian in what appears to have been an extrajudicial execution.

I welcome the investigation into his killing and I hope the whole truth will emerge and that those responsible for his death will be brought to justice. I believe this must happen with respect to all the other human rights violations committed in Chile so that these atrocities may never recur. It is also clear that the amnesty law of 1978 constitutes an obstacle to clarifying past abuses and preventing their recurrence and that the law should therefore be repealed.

This year is being marked as the 500th anniversary of the arrival of Europeans in the American continent. It is therefore a particularly appropriate time to highlight the unresolved human rights abuses against the indigenous peoples of America including the case of NELSON WLADIMIRO CURINIR LINCOQUEO.

I urge your Excellency to support the human rights organisations in Chile which will have my continued support.
