De nuestra mayor consideración:

Los abajo firmantes, nos dirigimos a Usted con el fin de solicitar su intervención en la causa que se le sigue al ciudadano Juan Ramón Díaz Olea, detenido el nueve de Noviembre de 1984. Díaz Olea, junto a otros cuatro pobladores de La Legua fue detenido y acusado de un asalto a la Décima Comisaría el día cuatro de Noviembre de 1984.-

A mediados del año 1988, el Fiscal Enrique Olivares pidió un total de 185 años de presidio para los cinco acusados, fallo que se apeló por los abogados defensores ante la corte marcial. Este, sin embargo, ratificó la decisión del magistrado castrense. Ni el fiscal, ni el tribunal de alzada tomaron en cuenta los testimonios de decenas de testigos que desmintieron la versión oficial y declararon que los cinco inculcados estaban en su casa, en la parroquia de La Legua, o en la calle de la población al momento del atentado. Todo esto demuestra que no estuvo garantizada la necesaria imparcialidad de todo juicio.-

Solicitamos la inmediata libertad del detenido Juan Ramón Díaz Olea, dado que la imputación que recae sobre él se basa en evidencia policial obtenida bajo presión, no habiendo pruebas imparciales que corroboren la acusación, constituyendo la continuidad de su detención una clara violación de la Declaración Universal de los Derechos Humanos.-


