Australia es también una sociedad de múltiples culturas, y el Gobierno del Estado de Queensland se ha comprometido a resguardar los derechos y la libertad de su población, la cual incluye a las comunidades indígenas y no indígenas.


En mi calidad de Ministro de Asuntos relacionados con los Aborígenes, he tenido la oportunidad de establecer la legislación de los Derechos de la Tierra en este Estado. Esto sucedió solamente después de prolongadas conversaciones y negociaciones entre el Gobierno y el pueblo indígena de Queensland. Creo que es este tipo de procedimientos el que permite que se llegue a un desenlace positivo y pacífico para todas las partes interesadas.
