Concerning the Death Penalty

As members ^{of} Amnesty International we applaud your opposition to the use of the death penalty in your country. We are writing to you now because we have heard of proposals to come before your Chambers of Congress to extend the use of the death penalty to those convicted of murdering off-duty policemen.

In no way do we condone violent crime. All murder is abhorrent and we believe that it is morally wrong for the state also to kill any of its citizens. There is no evidence that capital punishment deters murderers and in those countries which have abolished capital punishment there has been no increase in murders.

We would beg your legislature to abolish the death penalty and respectfully beg you to veto any legislation to extend its use.
