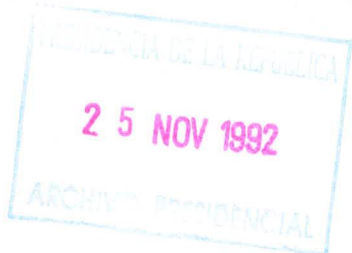

Your Excellency,

As a member of Amnesty International I am greatly concerned in the case of the "disappearance" of Alfonso Chanfreau Ayarce.

I am writing to beg you to make sure that his (and many others) case is not transferred to military jurisdiction.

Amnesty International is concerned about the impunity of those responsible for human rights violations during the former military government and urges the present government to ensure that those responsible are brought to justice so that the full truth in cases like that of Alfonso Chanfreau Ayarce can be revealed.

Please ask the government to repeal the 1978 Amnesty Law (Decree Law 2191) which has prevented and continues to obstruct full judicial investigations into abuses committed before 1978.

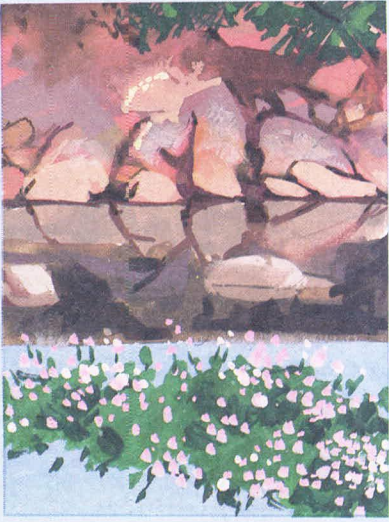
Alfonso Chanfreau and some 957 other people are known to have "disappeared" after their abduction by members of the security forces. It is hoped that the investigations into these cases remain in the civilian court where justice must be done.


Estimado señor Alcalde:
